

# SIGNS AND SYMPTOMS

#### PHARMACOLOGICAL EFFECTS

- Relaxation
- Euphoria Relaxed Inhibitions
- Disorientation
- Sedation
- Altered time and distance perception

#### POSSIBLE EFFECTS OF CANNABIS

- Interferes with divided attention
- Brief attention span
- Loss of Depth of perception

# CHARACTERISTIC INDICATORS OF SMOKED MARIJUANA

- Odor of Marijuana
- Marijuana debris in mouth
- Possible green coating on the tongue
- Cotton Mouth
- Reddening of the conjunctivae
- Body Tremors
- Eyelid tremors
- Dilated pupils (may be normal)
- Elevated pulse/blood pressure

# CHARACTERISTIC INDICATORS OF VAPED THC OR BHO AND EDIBLES

- Reddening of the conjunctivae
- Body tremors
- Eyelid tremors
- Dilated pupils (may be normal)
- Elevated pulse/blood pressure

# ONSET AND DURATION OF MARIJUANA'S EFFECTS

#### Smoked/Vaped

- 8-9 seconds User begins to feel and exhibit effects
- 10-30 minutes Peak effects are reached
- 2-3 hours User continues to feel and exhibit effects
- 3-6 hours User feels "normal"

#### **Consumed Orally**

- 20-30 min- User begins to feel and exhibit effects
- 1-3 hours Peak effects
- 6 +/- hours effects are still felt

- Impaired performance will be evident on Modified Romberg Balance, Walk and Turn, One Leg Stand and Finger to Nose
- Finger Count, Alphabet, Count Backwards

#### CANNABIDIOL

- Cannabidiol—CBD—is a cannabis compound that has significant health benefits, but does not make medical marijuana patients feel "stoned," and can actually counteract the intoxicating effects of THC.
- Relief from inflammation, pain, anxiety, psychosis, seizures, spasms, and other conditions without disconcerting feelings of being "high."

Extensive scientific research (much of it sponsored by the US government) and limited clinical studies underscore CBD's potential as a treatment for a wide range of conditions, including arthritis, diabetes, alcoholism, MS, chronic pain, schizophrenia, PTSD, depression, antibiotic-resistant infections, epilepsy, and other neurological disorders. CBD cannabis has demonstrable neuroprotective effects, and the anticancer properties of CBD are being investigated at several academic research centers in the United States and elsewhere
